Purchase Agreement/Health Guarantee

Thank you for deciding to purchase one of our puppies. We want to make this a stress free enjoyable experience for you. Please feel free to email or call me with any questions or concerns that you might have along the way. We will keep you up to date with information about your puppy as it grows until it is time for your puppy to go to its new home.

This agreement/guarantee is written for the protection of both the breeder and the buyer - However, it is primarily written to protect the health and general well being of the puppy.

Purchase Agreement

- 1. Please read the entire document completely before putting a deposit on a puppy. By putting a deposit on a puppy, you are agreeing to the terms and conditions within this agreement/contract.
- 2. We require a \$500-dollar deposit in order to hold the puppy of your choice. The deposit can only be in the form of a check or cash. **Balance due is to be paid in cash.**
- 3. This deposit is refundable up to the point of picking your puppy. After you pick your puppy, if you back out of purchase, it is no longer refundable. However, during your 72 hour vet check, if the vet finds a congenital health problem with the puppy, the buyer could return the puppy and have their choice of a full refund or could transfer their deposit towards another puppy or a future litter as long as we are still breeding. After the 72 hour vet check, we do not offer any refunds.
- 4: You are agreeing to purchase a: Teacup, Toy or Miniature Shepherd Puppy for: \$______. Your new puppy must be paid in full by the time you pick it up at 8 weeks of age by **PayPal Friends and Family or Cash.**
- **Please be certain that you are ready for the financial and time commitment involved in owning a puppy prior to putting a deposit on one. **

Health Guarantee

- 1. It will be up to us, the breeders, to decide when the puppy will be ready to go to its new home. Usually at the age of 8 weeks, depending on the breed, weight of the puppy and how easily it is weaned from the mother. We will not, under any circumstances, let the puppy leave before it is ready. There is an additional \$10 a day charge for puppies kept longer than 8 weeks of age.
- 2. The puppy is guaranteed to be in good health at the time of sale.
- 3. The puppy will be up to date on shots and worming at the time of pick-up of the puppy. It is very important that you continue the vaccinations and worming. Please do not expose your puppy to other dogs that are not

- vaccinated until he/she has completed the entire vaccination schedule around 16-20 weeks old. We do not recommend taking puppy to dog parks till puppy has been fully immunized.
- 4. The puppy will have been vet checked, dew claws removed, and tails docked and deemed in good health at the time of sale. Only Jane's puppies will keep their tails.
- 5. The buyer, at their own expense, agrees to have the puppy examined by a licensed vet within 72 hours of receiving the puppy. Please make this appointment once we give you your pickup date, to be sure it is within the 72 hour time frame.
- 6. Documentation must be sent to the breeder within ten days in order for the Health Guarantee to be honored.
- 7. If within 72 hours, a licensed vet finds the puppy to be unhealthy or unfit for sale, the puppy may be returned for a full refund provided the puppy has not been injured or neglected. The veterinarian must provide a written statement deeming the puppy "unhealthy for purchase".
- 8. This guarantee does not cover any health issues caused by neglect or injury from the buyer.
- 9. This guarantee does not include minor illnesses and health issues such as colds, allergies, internal or external parasites or umbilical hernias. However, the breeder will disclose any known illnesses or health issues prior to the sale.
- 10. The breeder can not assume responsibility for this puppy after 72 hours of the sale. It is the responsibility of the buyer to care for the puppy properly and keep it free from harm. Please remember that your puppy must be treated with great care and protected from danger.
- 11. The breeder assumes no responsibility for any medical expenses incurred after the sale.
- 12. The breeder does not guarantee size. We will give the buyer the weight of the puppy's parents and the weight of other puppies out of that mating. We can give the buyer an educated guess as to full grown weight, but there are too many variables besides genetics. We also cannot guarantee ear style.
- 13. The puppy is strictly sold as a **QUALIY PET**. Puppies will be spayed or neutered before leaving our facility. The vet who spayed your puppy is Dr Brooker from Fremont Animal Hospital (231) 924- 4940
- 14. Your puppy is registered thru the American Stock Dog Registry. An ASDR registration certificate will be applied for in your name. American Stock Dog will send the registration certificate directly to you. My Toy Aussie pays for the registration papers a part of the purchase price of your puppy. If you do not receive your papers within 30 days of purchase, it is your responsibility to follow up with breeder. Breeder will then follow up with ASDR.
- 15. The breeder is not responsible for puppies which develop Hypoglycemia after the puppy is in the new owner's possession. The buyer will receive information on what to do if this occurs. Puppy will need food in front of them 24/7.

- 16. The breeder gives an 18 month guarantee against any congenital defects of the puppy, from date of pickup/sale. If this should occur then the puppy will be returned to the breeder, and the buyer will receive another puppy of the same breed when there is one available.
- 17. If your puppy dies from a congenital condition, please contact us immediately. An autopsy will be required to show proof of heredity condition. Written verification and autopsy report should be mailed to us.
